Payment Policy

The balance of your tour payment is due 60 days prior to the departure date. If the tour you select begins within 60 days of booking, final payment is due at that time. Failure to receive the remainder of your trip balance by the due date will be considered a cancellation.

Cancellation Refund Policies

All cancellations must be made in writing. Cancellation fees are according to the following table:

Cancellations received 121 or more days prior to trip start: 100€

Cancellations received 120 – 61 days prior to trip start: 300€

Cancellations received 60 – 31 days prior to trip start: 50% of trip price

Cancellations received 30 days or less prior to trip start: 100% of trip price

No refunds will be issued due to the late arrival / early departure / unused portion of a tour. If we are notified of tour date changes 5 months prior to the start of your originally scheduled tour, you can apply your tour deposit to another tour date without penalty. This tour date can be up to 1 calendar year in advance and is subject to availability. Otherwise, the above Cancellation Fees will be applied.
